

Town of Prospect Legal Notice - Assessor's Office

All persons liable to pay taxes on Personal Property in professional, commercial or business occupations in the Town of Prospect are hereby required by law to return to the Assessor's Office on or before November 1, 2006 (unless granted an extension by the Assessor) a written or printed list of such taxable personal property owned by them on the 1st day of October, 2006.

Those failing to make such a list will be assessed an additional twenty-five (25) percent penalty, according to law. Requirements have changed since last year. Read instructions carefully prior to completing the form. Lists are available in the Assessor's Office, Monday through Friday, 8:30 a.m. to 4 p.m.
