

## Town Hearing Set in Prospect for September 5

At the next Prospect Town Council meeting, there will be a hearing regarding an upcoming inter-municipal agreement between the City of Waterbury and the Town of Prospect. The agreement is regarding the active adult community on Scott Road in Prospect and its plan to be hooked up to Waterbury's sewer line. A discussion will take place between the Prospect Town Council and the Water Pollution Control Authority.

Immediately following the discussion, the Town Council will vote whether or not to give the Mayor and the Water Pollution Control Authority permission to sign the agreement.

A draft copy of the agreement will be available at the meeting. However, to be final, the agreement must also be approved by the City of Waterbury.

The Town Council meeting will be held on Tuesday, September 5 at 7 p.m. at the Prospect Town Hall. The public is invited and encouraged to attend.
